Students engage in using technology for research, data collection, class presentations, and lessons planned for presentation in field work and student teaching. Use of technology as a strategy for collection, management, and analysis of assessment data is the focus of both EDUC 3155 Developmental Assessment I and EDUC 3165 Developmental Assessment II. In both courses, students are required to complete field assignments targeted for building competencies in these areas. Candidates obtain competencies in the areas of universal design for learning, utilization of SMART classroom technologies, and implementation of technology software designed for a diverse range of learners in diverse disciplines. In addition, EDUC 2160 Electronic Media for Teachers is now being taught by an adjunct who is the Technology Specialist for the local Intermediate Unit.
