# Field Hockey

# returns to Keystone College

The Keystone College athletics department looked to its past to get a glimpse of its future.

Dr. Matthew Grimaldi, director of athletics, has announced that beginning with the 2008-2009 academic year, the sport of field hockey will join the list of intercollegiate varsity programs sponsored by the College.

Field hockey will become the 16th varsity sport at Keystone, joining men's and women's soccer, cross country, tennis, basketball, indoor track and field, outdoor track and field, women's softball, men's baseball, and men's golf.

"We are thrilled to be able to once again offer the sport of field hockey at Keystone College," stated Dr. Grimaldi. "Field hockey has a rich tradition in the region and was the logical choice to be added to our varsity lineup."

Field hockey began at what was then Keystone Junior College in 1971 when the institution competed as a member of the National Junior College Athletic Association (NJCAA). Keystone teams competed for 18 years (1971-1988), with 17 seasons under the tutelage of program founder and head coach, Marge Philbin. Ms. Philbin was inducted into the Keystone College Athletics Hall of Fame in October of 2006.

During the program's initial span, Keystone compiled a mark of 91-96-19, with the highlight coming in 1977 when Keystone advanced to the NJCAA National Championship contest. The Giants advanced to the Region XIX championship tournament on nine different occasions, including a streak of eight straight appearances from 1976 to 1983. For its efforts, the 1977 field hockey team was inducted into the Keystone

College Athletics Hall of Fame in October of 2007.

The program was dropped following the 1988 season because there were too few potential opponents, as many junior colleges began to eliminate field hockey programs.

Kacy Parry will take the reigns of the field hockey program when the team begins play this year. Kacy also serves as the College's NCAA compliance officer. A graduate of East Stroudsburg University, Kacy has enjoyed success as a field hockey player on both the high school and collegiate levels.

While a member of the Lackawanna Trail High School team, the Dalton, Pa., native was a four-year starter and letter winner. She earned All-Conference honors on three occasions and was also named a Pennsylvania All-State performer on two occasions.

"I am looking forward to getting started and showcasing all the College has to offer to potential student-athletes. Keystone has shown a strong commitment to its athletic programs and I will look to continue that quality and dedication that is so evident here," Kacy said.

## Keystone Hosts National Forensics Syposium

Call it CSI-La Plume!

That's right. Some of the top crime scene investigators in the nation visited Keystone College on Saturday, April 19 when the Keystone Forensic Science Club hosted its second annual Undergraduate Forensic Science Research Symposium.

The symposium brought together students, professors, and other experts to discuss the latest topics in forensic science. Guest speakers for the event included King Brown and Dawn Watkins, two of Florida's most experienced crime scene investigators. The day-long event was held in Hibbard Campus Center.

"This was a great opportunity for our students to interact with some of the most respected forensic science professionals in the nation," said symposium coordinator and assistant professor of forensic biology Tammy Barrette, J.D. "Presentations by King Brown and Dawn Watkins were definitely the highlights of the symposium."

King Brown is a crime scene supervisor for the West Palm Beach, Fla. Police Department. A certified senior crime scene analyst, he supervises a 10-person crime scene department.

Before taking that assignment, Mr. Brown served as a crime scene investigator for the Hollywood, Fla. Police Department for 14 years. He has been involved in numerous criminal investigations of all types and has received a variety of accom-



modations and awards, including the city of Hollywood's Meritorious Service Award. He has a master's degree in criminal justice from Florida International University and is an adjunct professor at Palm Beach Community College.

Dawn Watkins is a certified latent print examiner and certified senior crime scene investigator with the Palm Beach Gardens Police Department. Like Mr. Brown, she is regarded as an expert in her field and has been involved in extensive crime-scene investigations and analysis.

After a 10-year career as an FBI fingerprint analyst, she received extensive training during 18 years with the Hollywood, Fla. Keystone student Melissa Dutkevitch conducts a forensics experiment on campus.

Police Department as a fingerprint examiner. Upon retirement from the Hollywood Police Department, Ms. Watkins worked with the Coral Springs, Fla. Police Department before joining the Palm Beach Gardens police force. Ms. Watkins received a master's degree in criminal justice and teaches and lectures at numerous professional associations and educational institutions.

"Jim is an incredibly creative and intelligent young man who has a very bright future ahead of him," Dr. Lee said. "He and his team worked especially hard and narrowly missed taking home first prize."

"This has been a great 'real world' experience for me," Jim said. "I have been able to apply what I have learned in the classroom. Now I can use this experience as I continue my college and business careers."

# **Dr. Warren** and **Helen Yeisley**Remember Keystone College in a Unique Way

Keystone College was truly a special place for Dr. Warren Yeisley.

After receiving his associate's degree in engineering from what was then Keystone Junior College in 1959, Dr. Yeisley continued his education at Penn State University, earning a bachelor's degree in electrical engineering and a doctorate in biophysics. He also pursued post-doctoral studies at Yale University.

Dr. Yeisley then pursued a long and successful career in biophysics and computer engineering with Wyeth Pharmaceuticals and other top bio-medical corporations. Through all of those educational and professional experiences, the New Milford, Pa. native never forgot his roots in rural Northeast Pennsylvania and he never forgot Keystone College.

That's why Dr. Yeisley -- who passed away in 2006 -- and his wife, Helen Yeisley, have remembered Keystone with two very special gifts.

The Dr. Warren G. Yeisley Scholarship for Keystone College Environmental Educa-

tion Institute (KCEEI) Teachers will be awarded annually to teachers from the Blue Ridge, Pa., School District. The scholarship will fund teachers' attendance at KCEEI's annual forest and society course, or similar KCEEI courses. Also, Mrs. Yeisley has established a scholarship to be awarded in the fall of 2008 to a student in Keystone's environmental resource management program.

"Warren felt an intense loyalty to Keystone. He felt it served as a springboard for the rest of his life. Keystone helped get him started and he just kept on going," Mrs. Yeisley said.

In addition to their affection for Keystone, Dr. and Mrs. Yeisley also had a deep appreciation for the outdoors. In 2004, they purchased several acres of land in Susquehanna County on which they hoped to grow hard-wood trees such as the beautiful black cherry tree. The couple resided in Teaneck, N.J., but visited Northeast Pennsylvania as often as possible.

When Mrs. Yeisley was seeking an appropriate way to honor her husband's memory, she toured the Keystone campus and met with KCEEI Director Professor Howard Jennings. Mrs. Yeisley appreciated seeing where her husband received his early college education and became familiar with KCEEI's mission of assisting elementary and high school science teachers.


The gift to KCEEI and the 2008 environmental science scholarship helped express her gratitude. The KCEEI scholarship will be used exclusively for teachers from the Blue Ridge School District, Dr. Yeisley's hometown school district.

Funded in part by the U.S. Forest Service through the Education Research Consortium of the Western Carolinas, Inc., KCEEI provides hands-on, inquiry-based science and environmental education to professional educators using nature as a laboratory.

"We are tremendously grateful to Dr. and Mrs. Yeisley for the establishment of this KCEEI scholarship for teachers in the Blue Ridge School District," said Professor Jennings. "Their gift will enable teachers to better serve their students for many years to come."

That is exactly what Dr. Yeisley would have wanted.

"Our purpose is to give back to Keystone College and to the local community. These gifts seemed like a perfect way to honor Warren's memory," Mrs. Yeisley said.



respected community weekly newspaper, voted Keystone as the Scranton area's most beautiful college campus in its recent survey.

But a beautiful campus is only a great benefit if it can be sustained and improved over time. That has been the goal of Keystone College's leaders since its founding in 1868 and is of preeminent importance today. Under the leadership of President Dr. Edward G. Boehm, Jr., Keystone has been at the forefront of the sustainability movement locally and nationally.

"Our mission is very clear. We want to do everything in our power to protect, maintain, and preserve the natural beauty of Keystone College," President Boehm said. "This is a promise we owe to those who have come before us and to those who will be here long after we are gone."

With that objective in mind, Keystone College has undertaken a variety of important environmental and sustainability initiatives that will produce immediate and long-term benefits.

Many of these initiatives are being implemented through partnerships with Sodexo, the international company responsible for Keystone's facilities and dining services. Others have come in conjunction with long-time campus partners

such as the Keystone College Environmental Education Institute and the Countryside Conservancy.

The following are some of the major initiatives undertaken by Keystone to protect and preserve the environment:

# The American College and University Presidents Climate Commitment

Keystone has become a charter member of the American College & University Presidents Climate Commitment (ACUPCC), an organization consisting of college presidents banding together to make a direct impact on one of the most challenging issues of the 21st century.

As an ACUPCC signatory, Keystone and other members jointly agree to develop plans for their respective institutions to reduce and ultimately neutralize greenhouse gas emissions on campus and to accelerate research and educational efforts to protect and preserve the environment.

"Keystone College is extremely honored to join colleges and universities throughout the United States in this important initia-

tive," President Boehm said. "Keystone is located on beautiful fields, gardens, and woodlands. The south branch of Tunkhannock Creek runs through our campus. Because of this rustic, natural setting, Keystone has always been keenly aware of the importance of maintaining and sustaining our natural environment. Becoming a member of the American College and University Presidents Climate Commitment is another historic step in that direction."

Other well-known universities participating in the effort include, Cornell University, Syracuse University, the University of North Carolina, the University of Florida, and the University of Colorado.

#### **Wind Power**

Keystone College has begun a test process as the first step to ultimately producing wind-powered electricity on campus by 2009. Solair Energy, Inc., a renewable energy company based in Ralston, Lycoming County, Pa., has installed an 80-foot temporary test tower which will measure the campus' capacity to generate electricity through wind-driven means. The tests will reveal the best locations to install wind-powered turbines and help determine the

specific types of turbines that should be constructed.

The wind-resource assessment will be conducted by Keystone College environmental science students in conjunction with faculty and industry professionals. The tower will be placed at various locations on campus during the next two years. Its initial location is near the Area Health Education Center (AHEC) on the eastern part of campus.

After the test period is completed and accurate readings are obtained, a decision can be made regarding the best locations to construct several wind-powered turbines which will generate electricity for campus use. The turbines will be approximately 100 feet high, about the same size as the tower for Keystone's radio station.

Keystone currently derives 10 percent of its electricity from wind-power provided by PPL Electric Utilities. When the wind turbines are eventually constructed on campus in 2009, the use of power from hydrocarbon fueled sources will be further reduced.

#### **Environmental Partnerships**

Keystone College continues to work with our valued partners to help promote environmental awareness.

Keystone College's Environmental Education Institute (KCEEI) is funded in part by the USDA Forest Service through the Education Research Consortium of the Western Carolinas, Inc. KCEEI, under the direction of Professor Howard Jennings, is committed to enhancing the teaching experience by providing hands-on science and environmental instruction to educators using nature as a laboratory.

Also located on the campus is the Willary Water Resource Center, dedicated to providing public education in water-related issues and fostering public involvement in watershed activities. Keystone College and the Lackawanna County Conservation District jointly operate the facility, creating a unique partnership between local government and a private institution.

The **Countryside Conservancy**, also on campus, encourages conservation in Lackawanna, Wyoming and Susquehanna counties by providing assistance to landowners who want to preserve their lands and watersheds.

The Mid-Atlantic Center for Urban and Community Forestry, is part of the USDA Forest Service, Northeastern Area, Urban and Community Forestry Program,

providing assistance in the development and transfer of innovative tools and technologies to assure healthy functioning urban forests for generations to come.

Keystone College, in conjunction with the Overlook Estate Foundation, also operates the "Sugar Shack," which produces and bottles delicious home-grown maple syrup from our own maple trees.

Keystone College has established several outdoor laboratories on campus, including a hydro-geologic well field and several continuous water quality monitoring stations.

#### Campus Improvements

There have been significant environmental enchancements to our campus as well.

- The roof on the Miller Library has been replaced with a new Energy Star compliant roof. The new roof is not only designed to eliminate leaks, but will also significantly reduce the air conditioning load in the warm summer months.
- Keystone College has purchased four electric vehicles from Vantage Vehicles of Yorba Linda, Calif. The vehicles will replace three gas-powered vans and one automobile and will be used by campus safety officers and Sodexo campus facility employees. The switch to electric-powered vehicles will reduce carbon emissions on campus.

#### Campus Dining and **Maintenance Services**

Keystone and Sodexo, also work together to promote environmental sustainability in several ways:

> • Keystone participated with over 375 colleges and universities in "Recyclemania," a national recycling competition. The competition, which ran from January 27 through April 5, featured a variety of on-campus activities designed to help the College community realize the importance of recycling to protect and sustain the environment. The Keystone community recycled over 10.3 tons of cardboard, 2.28 tons of paper, and just over 2 tons of plastic bottles and cans.

 Trayless Tuesdays also help save about 1,000 gallons of water per week. Each Tuesday trays are not used in the cafeteria, meaning no water was needed to wash them. The amount of food consumed by students also decreased by about 2 ounces per tray. Local ABC affiliate WNEP featured Trayless Tuesdays as part of an ongoing environmental series.

efficiency.

- Students were challenged to conserve as part of Sodexo's "Weigh the Waste" program. Each week, Sodexo measured the amounts of recycled waste collected in the student cafeteria, and students were challenged to decrease that amount in subsequent weeks.
- All kitchen soaps and dishwashing products are chemical-free "green products."
- All cardboard, plastic and fryer oil is recycled.

- Sodexo has introduced bio-degradable silverware and plates, available to groups who request them.
- Milk is supplied by Lehigh Valley Farms, which purchases much of its milk from local dairy farms in Wayne County.
- Pennsylvania-grown organic products are used in Keystone dining facilities.

These projects and many others like them will help keep Keystone at the forefront of the sustainability movement for decades to come. That's a promise worth keeping for current Keystonians and for future generations who are relying on us to make our campus, our nation, and our world a better place to live.

# Keystone Graduate **Chris Yeakel '05**Strives to Maintain Environmental Balance

As the world's need for energy continues to soar, a Keystone College graduate is putting his talent and education to productive use by helping our nation preserve its environmental resources.

Christopher Yeakel '05, serves as an environmental biologist with the Federal Energy Regulatory Commission. Working within the Land Resources Branch of the Office of Energy Projects, Chris is responsible for approving applications for a variety of activities at non-federal project sites involving hydropower, including construction of private boat docks, commercial marinas, public access to water ways, and recreational facilities.

Specifically, he reviews and approves applications to ensure they are consistent with environmental laws and habitat management guidelines. To achieve this goal, Chris often consults with state historical preservation officers, the United States Fish and Wildlife Services, and the Federal Bureau of Land Management.

Achieving the delicate balance between environmental and economic benefit can be a difficult task. Chris must consider property owners, local residents, and environmental issues when making a licensing decision. In addition to the licensing approval process, Chris also deals with compliance issues. If an alleged transgression takes place, he completes a review of the project history and circumstances and determines if the licensee acted appropriately.

While at Keystone, Chris was a familiar and friendly face across campus, active in many environmental activities and research projects. The environmental resource management graduate supported his academic studies by working full time with the College's Physical Facilities department. "Keystone College provided a unique and unparalleled learning experience," Chris said. "A comfortable and close-knit learning environment allowed me to develop the skills necessary for professional success."



Chris had an avid interest in the environment and outdoors while growing up in nearby Factoryville, Pa., and that interest helped him in choosing his career path. "The world around us affects our everyday lives. It is extremely important that we all serve as stewards to our environment."


