These courses include: SPEC 2115 Special Education Processes and Procedures (includes instruction on the IEP process), SPEC 2120 Early Intervention and Transitions, SPEC 3125 Evidenced Based Effective Instruction; and SPEC 4110 Family Partnerships: Advocacy, Collaboration, and Transitions. To maximize instructional effectiveness, Special Education teacher candidates must also complete coursework in high incidence disabilities (SPEC 3130 Learning Disabilities: Identification and Instruction in Content Areas) and low incidence disabilities (SPEC 3120 Low Incidence Disabilities: Assessment and Instruction).
