Options A - Notary

- 1) The below (page 3) notarized Identity Statement
- 2) A copy of the unexpired valid government-issued photo identification (ID) that is acknowledged in the notary statement below, or that is presented to a notary, such as, but not limited to, a driver's license, other state-issued ID, or passport;

Options B - Video call with School (as applicable)

- 1) Present an unexpired, valid, government-issued photo identification by appearing on a video call to an institutionally authorized individual who will review the identification.
- 2) The institution must retain a copy—electronic or hardcopy—of the identification document, including the date it was presented and the name of the authorized representative who reviewed it. This requirement can be met by capturing a screenshot of the video call, provided the identification details are legible.
